ORDER:

Pursuant to Rule 50 of the Central Motor Vehicles Rules, 1989 as notified by the Government of India, Ministry of Road Transport and Highways vide Gazette Notification No.221(E) dated 28/03/2001 and SONo.814 (E) dated 22/08/2001 & SO No.1041 (E) dated 16/10/2001, SO No.883(E), dated 12/06/2006 and SO No.2091(E), dated 16/09/2011 to introduce New High Security Registration Plate System (NHSRP hereinafter) in India and also in pursuance of the Order of Hon'ble Supreme Court of India in Writ Petition No.510/2005, dated 8.5.2008 read above the Governor of Andhra Pradesh hereby makes and notify the following scheme for the implementation of the New High Security Registration Plates Project in the State of Andhra Pradesh.

2. The following Notification will be published in the Extraordinary Issue of the Andhra Pradesh Gazette, Dated: 03/12/2013.

NOTIFICATION

1. This Scheme shall be called "The New High Security Registration Plates Project Scheme, 2013".

2. The Scheme shall come into force w.e.f. 11/12/2013 in case of new vehicles.

3. As far as in-use vehicles are concerned, the task of implementing the Scheme shall be completed by 10/12/2015.

4. The Government of Andhra Pradesh have selected and approved M/s LINK AUTO TECH PRIVATE LIMITED, D-34, BASEMENT, JUNG PURA EXTENSION, NEW DELHI - 110014, to sell and affix High Security Registration Plates in Andhra Pradesh at the rates excluding the applicable Duties and Taxes as approved below:-

NOTE: The final prices of HSRP after adding Excise Duty and VAT for different categories of vehicles/Individuals Plates to be rounded off to the nearest Rupee.

5. The Registration Plate will be supplied to the motor vehicle owners by M/s LINK AUTO TECH PRIVATE LIMITED, D-34, BASEMENT, JUNG PURA EXTENSION, NEW DELHI – 110014 against the authorization by the Registering Authority or any Officer designated for the purpose by the State Transport Department.

6. The replacement for any existing registration plate may be made by the Registering Authority concerned after ensuring that the old Number Plate has been surrendered and in case it is lost or destroyed, on receipt of a certificate from the Station House Officer having jurisdiction in the matter to the effect that the plate concerned was destroyed irretrievably or lost irrecoverably.

7. M/s LINK AUTO TECH PRIVATE LIMITED, D-34, BASEMENT, JUNG PURA EXTENSION, NEW DELHI – 110014 shall adhere strictly to the provisions of amended Rule 50 of Central Motor Vehicles Rules, 1989 and The Motor Vehicles (New High Security Registration Plates) Order, 2001 as amended from time to time.

8. The NHRP shall conform to Rule 50 and Order, 2001 as amended from time to time. No other mark of indications like name of owner, Department, etc., shall be written/added on New High Security Registration Plate.

9. In case of three and four wheel vehicles, a Third Registration Plate in the form of a self-destructive type sticker containing Laser branded Identification Number, Engine Number, and hologram, shall be affixed on the windshield of the vehicle. This shall also

be procured by the vehicle owner from the authorized vendor as mentioned in Para 5 above.

10. The New High Security Registration Plates (including the Third Registration Plate required as per Para No.9) shall be fastened/affixed by M/s LINK AUTOTECH PRIVATE LIMITED, D-34, BASEMENT, JUNG PURA EXTENSION, NEW DELHI – 110014 on the vehicle within the premises of the concerned Registering Authority who allotted the new number in the presence of Registering Authority or his authorized representative. No High Security Plate shall be affixed outside the premises of the office of the Registering Authority concerned.

11. A proper record of New High Security Registration Plates issued by M/s LINK AUTOTECH PRIVATE LIMITED D-34, BASEMENT, JUNG PURA EXTENSION, NEW DELHI – 110014 shall be maintained by them on a daily basis and got tallied weekly with the records of the concerned Registering Authority as per specification No. (xiii) of The Motor Vehicles (New High Security Registration Plates) Order, 2001.

12. The Registering Authorities are required to follow Rule -50 of Central Motor Vehicles Rules, 1989 and other rules governing the NHRP, The Motor Vehicles (new High Security Registration Plates) Order, 2001 as amended from time to time by Government of India and any other instructions issued by Government of India or Government of Andhra Pradesh from time to time while dealing with New High Security Registration Plates.

13. Each Registering Authority of Andhra Pradesh Transport Department will maintain e-record of the data regarding the High Security Registration Plates affixed/fastened on the vehicles concerned.

14. Each Registering Authority shall request for periodic audit to be carried out by concerned agency as listed in Order, 2001 and Rule 126 of Central Motor Vehicles Rules, 1989 to ensure compliance of the requirement of the New High Security Registration Plate.

15. To achieve the objectives of Rule 50 of the Central Motor Vehicles Rules, 1989 and the Motor Vehicles (New High Security Registration Plates) Order, 2001, the Government of Andhra Pradesh may from time to time issue instructions to regulate the installation of New High Security Registration Plates for the motor vehicles on the rolls of the Registering Authorities of Andhra Pradesh.

16. No Agent other than the Contractor shall be involved in the process of implementation of High Security Registration Plates project, in the State of Andhra Pradesh.
